Note: Your data will NOT be saved and you will access a fresh form.

In a 'sole/uncontested' divorce, you are the applicant, your spouse is the respondent. Your spouse must be served with a copy of the Application for Divorce after it is filed with the court. If he or she does not file an Answer within 30 days of being served, the divorce will continue as 'uncontested'. In a 'joint' divorce both spouses must sign the required divorce forms. In both cases, ezDivorce files 'simple divorces' only - meaning the only request you wish to make is for a divorce.
